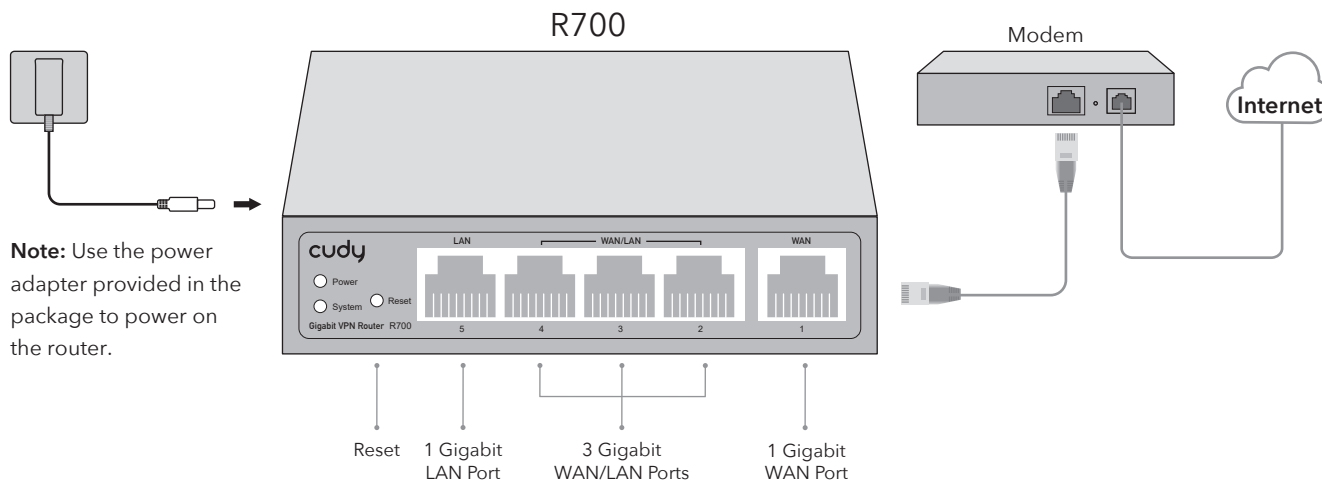

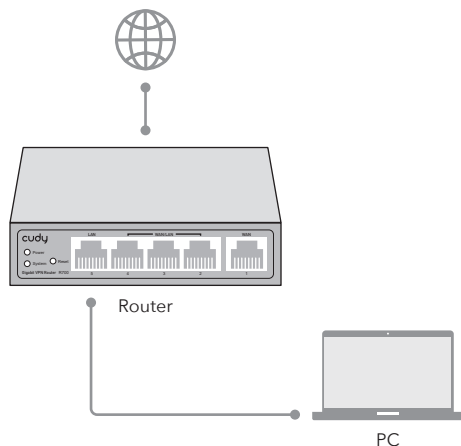

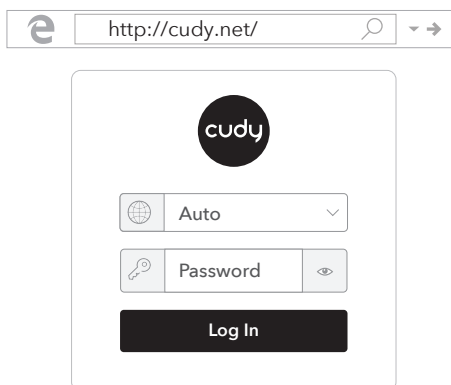

- 1 Connect a computer to the LAN port of the router with an RJ45 cable properly. If your computer is configured with a fixed IP, change it to Obtain an IP address automatically.



- 2 Launch a web browser, and enter **http://cudy.net/** or **http://192.168.10.1/** in the address bar. Use **admin** for password to log in.

- 3 After a successful login, you can configure the function by clicking the menu on the top of the screen.

	Blinking: Transmitting or receiving data
Reset	Press and hold 6 seconds to reset the router to its factory default settings.

A1: If the computer is set to a static IP address, change its settings to obtain an IP address and DNS server address automatically.

A2: Verify that <http://cudy.net/> or **192.168.10.1** is correctly entered in the web browser .

A3: Use another web browser and try again.

A4: Reboot your router and try again.

A5: Disable and then enable the network adapter being used.
